Community members called ‘to walk humbly with our God’

Micah exclaims - ‘**With what shall I come before the Lord? In whatever walk of life we lead, as Christians, I want to suggest that we come empty handed, having nothing, possessing nothing. We come knowing that everything belongs to the Lord. It is his kingdom and we are his people.**

However as we come this afternoon, we recognise that God has placed us in a very special place, and has given us special responsibilities amongst his people who are precious to him. How can we possibly fulfil the task he places before us? That passage in Micah ends by telling us what the Lord requires **and it is to ‘do justice, and to love kindness (or mercy in some versions), and to walk humbly with your God’.** These are three qualities which embrace the essence, the inner distinctive nature of Pilsdon. Our Guardian, Peter, and the community members, go to great lengths to seek *justice* for deserving causes, to help the underprivileged, the marginalised and those who need a helping hand. There is a spirit here **in this place which reflects Paul’s teaching that ‘there is neither Jew nor Greek, male or female, slave nor free’. There is no partiality of any kind and equality is sought for all.**

The second quality is ‘to love mercy or kindness’ and this embraces that second summary of the law that Jesus gave – ‘to love your neighbour as yourself’.

I remember a song we used to teach **youngsters; the words went like this ‘Mercy is when God gives us the things we don’t deserve!’** Pilsdon holds its hand out to anyone who want to be given a chance, a new start, but all community members and guests alike have to accept the ethos here. Our reading from **Acts enlightens us to the key of that ethos ‘they had all things in common ... distributing to all as any had need. Day by day they spent time together, they broke bread in their home and ate their food with glad and generous hearts’.** Here in this place everyone shares in

community living, sharing meals, working together and respecting one another and accepting one another – loving kindness in action.

Later we will hear how Jesus read a passage from Isaiah when he went to the synagogue on the Sabbath. A passage which Jesus declared he had fulfilled in their hearing. His fulfilment is an example for us as a community to follow. May the Spirit of the Lord ever be upon this place, may he anoint us all, but especially the community members, to bring good news to the poor. May he enable us to proclaim release to the captives, release to whatever is binding the lives who come here. May we too open the eyes of people to the love of God and help them to rebuild broken lives.

But returning to the Micah passage, **most important of all is ‘to walk humbly with your God’.** Pilsdon is also a place of prayer and praise, remembering our place before God and seeking to do his will and we will always be grateful to the nuns for welcoming the community here. Humility is not thinking we are better than anyone else. We always keep before us the example of Christ, who emptied himself, taking the form of a servant, and who, on the last night of his life, humbly washed his **disciples’ feet. Humility confesses that we have nothing that we have not received and admits the fact of our insufficiency and our dependence upon God.** In my own Franciscan tradition it is regarded as the first condition of a joyful life within any community.

So may those renewing their commitment or making it for the first time be **filled with the joy of the Lord as they seek ‘to do justice, and to love kindness, and to walk humbly with your God’.** **May the Lord bless you.**

Wasantha is welcomed back to the community

We welcome Wasantha back to the Pilsdon at Malling Community after an absence of six years. He originally came to West Malling as a Community Member, having been a volunteer at Pilsdon in Dorset.

He was part of the advance party that came here in May 2004 and kept the garden under control and looked after the place until the rest of us moved here in September. We are delighted that he has returned after doing great work helping Sri Lanka to recover from the devastating Indian Ocean Tsunami.

Wasantha Hettiarachchi returns to the community, and brings thanks for the Tsunami support in Sri Lanka. He writes:

The 2004 Boxing Day tsunami devastation did **change most of the coastal communities' day** to day life. The tsunami did change our life in many ways like the people of Japan are experiencing right now. From January 2005 to March 2008 I directly worked with the tsunami-affected communities in the southern part of Sri Lanka near Galle. I was working with World Vision Lanka (WVL), Tsunami Response Team in different capacities. Co-ordination and liaison between the government and the communities was one of my main responsibilities.

We did our best at that time and did support many families to return to their normal life, providing houses, supporting in their livelihood, providing water and sanitation facilities, upgrading education facilities and specially in child development, because World



Vision is a child-centered charity. From April 2008 to March 2011 I moved to WVL national office in Colombo as the Senior Community Based Disaster Management Co-ordinator to provide technical support to all our existing projects and to integrate disaster management in to long-term development concepts. I was able to start some prevention work, mitigating work and get community preparedness activities with our communities in many parts of the country. The 2004 Tsunami did teach us many lessons and the importance of disaster management.

I want to thank all who supported Sri Lanka during that difficult time, especially **Pilsdon's friends and the local churches**, and I hope all your contributions will help us to stand our own feet again. It is good to come back to the Community at West Malling.

Peter and Mary to retire (and Peter joins the hip-op generation)

We have announced to the Trustees of the Pilsdon at Malling Community that we intend to retire from the Community at the end of October this year. This will also mean that we shall also need to **leave the "House for Duty" post on Kings Hill. By the end of October both of us will be past retirement age and I will have been in full-time ministry for over 39 years – 22 years as a parish priest and 17 years in the Pilsdon Communities, including over 3 years at Kings Hill. We feel it is appropriate for us to retire at this time to facilitate a successor at the Community and also to give the Diocese and the two new priests to shortly be appointed to the parishes the opportunity of appointing a longer-term "House for Duty Priest" as has been agreed.**

In the meantime we have more immediate plans to announce, namely that Peter underwent hip-replacement surgery on April 5th. He will be unavailable for at least 6 weeks after that date. He has arranged for the services at Kings Hill and the Pilsdon Community to be covered during this time, which includes Holy Week and Easter (see details elsewhere). We are very grateful for the help of our colleague Pam for taking over the Pilsdon responsibilities and for Fr Peter Doodes and Fr Chris Dench assisting with some of the services.

Mary will be encouraging Peter's recovery at home, not least with transport, because Peter is not allowed to drive for at least six weeks. She will continue to visit her 96-year-old mother at weekends and emergencies.

I think it is outrageous and I am ashamed...

When I was a curate in Wolverhampton in the 1970s I became involved with two groups of people who were concerned about a strong tradition in Wolverhampton and the West Midlands for having industries and employment that relied on the manufacture of arms. One group was the Combined Shop Stewards of Lucas Aerospace together with some Quakers, the other was the Campaign Against the Arms Trade (CAAT).

The Combined Shop Stewards produced six volumes of documents setting out the technically viable means of using existing equipment and human expertise and skills to make socially useful products instead of weapons. This "Corporate Plan" was studied by our group and publicised and promoted in the churches and more widely. It tried to prove that the employment and skills of the arms industry could be maintained without making weapons of war. Sadly the companies and shareholders involved were not prepared to put up the capital for such a venture and felt more secure with arms.

The contemporary chapter of this story is that our Prime Minister has recently toured the Middle East with a retinue of arms manufacturers, following in the steps of others before them who had sold arms to the very countries that are now using them to suppress the

demonstrators who want freer and more democratic societies.

Our Government has excellent guidelines which say that we do not sell arms to countries involved in wars, to areas of high tension, to those with bad human rights records or those likely to use arms to oppress their own people. But we seem to ignore these guidelines and we sell arms, tear gas etc to Egypt, Libya, Saudi Arabia,



Bahrain, Algeria and Israel, to name just a few. Last November more than half the exhibitors at an arms fair in Libya – LibDex – were UK companies. CAAT has demonstrated that manufacturing for the export of armaments accounts for only 0.2% of UK jobs and only 1.5% of total exports.

And yet the British taxpayer, in a time of government cuts, subsidises this trade by about £500 million a year. (How many libraries, art projects, benefits and front-line services could that save?) When we see demonstrators on Arab streets being shot down, gassed and crushed by British-made arms and equipment we should be outraged and ashamed.

We should use every opportunity of expressing our outrage, because we have the democratic privilege of doing so.
